BACK TO COLLEGE for QISPs

Phew! Midterms and finals! Most people thought they left those behind when they graduated from college. But with the exciting launch of the new QISP training program on May 1st of this year, many QISP applicants will feel like they are back in their college years.

This QISP training program features high quality videos paired with knowledge-testing questions and scenarios that are on par with an online college program. This unique training program for QISPs has the best of both worlds as far as education goes. The QISP applicant gets to experience the online learning platform as well as a live all-day training class for the third day of the QISP certification process. These live one day classes, which are required to complete your QISP certification, are being offered all over the State of California. You can choose which live training class you want to attend by looking at the schedule that can be found [here](#) on the OWP website. Almost all of the one-day training classes have plenty of room available for more sign-ups. Although the QISP training program is receiving some attendance, over all, the program is not receiving as many participants as expected. Unsure of exactly why that is the case, we are assuming there is a lot of hesitation among QISP want-to-be's in getting their certification. Getting certified to be a QISP is an awesome goal! With no formal prerequisites required, the QISP training program is a great way to increase your field of work and knowledge about storm water. The QISP fact sheet (available [here](#)) defines the roles of a QISP as mainly relating to improving compliance, maintenance, and the quality of data submitted, as well as assisting the discharger and on-site personnel with storm water knowledge and with the implementation of the IGP requirements. As intimidating as this training program may seem, it is a great opportunity for protecting storm water and for assisting dischargers who are in Level 1 or Level 2 status.

If you are currently in the QISP training program and are just about ready to take the third day of training, WGR Southwest is offering its next day of live training on July 19th. Mark your calendars! What makes WGR Southwest's training day so special? Imagine taking your third day of training in the same studio and under the same host as all of your training videos! WGR Southwest also uses its unique location as a simulated industrial facility to give QISP students a realistic scenario to help learn the Industrial General Permit requirements. "To Do List" for June/July

- ☁ Complete your facility's annual report and submit via SMARTS by July 15.
- ☁ If your facility is moving into Level 1 status, begin the Level 1 process now – see Section XII.C in the Industrial General Permit for a list of things to do for Level 1. You will need to perform a Level 1 evaluation (assisted by a QISP) by October 1st of this year. Don't wait until the last minute!
- ☁ Perform your monthly non-storm water and BMP status inspection

Accurately Articulating Annual Reports

"The time has come, the consultant said, to talk of many things, of SWPPPs and QISPs and rain events, of annual reports and things...." Although Lewis Carroll might not have thought storm water to be as fun as Alice's Adventures in Wonderland, we here at WGR beg to differ. Storm water can be fun and annual reports prove that. These easy, simple-to-do reports are quite fun to complete! Let's dive into how to complete an annual report...

1. To begin with, you will need to have your Annual Comprehensive Facility Compliance Evaluation (ACFCE) inspection sheet completed and on hand for filling out the annual report questions. You will also need an up-to-date copy of the SWPPP for your site. With these two tools you are almost unstoppable. Most of the information you need are these two locations!
2. You will need to log onto your SMARTS account and click on the "REPORTS" tab on the left side of the screen after you have logged into your account. After selecting "REPORTS" you will need to enter in the reporting year. So for example, this year's reporting year would be 2015-2016.
3. After selecting the reporting year, the website will take you to the next page and you will need to select the site which you are filling out the report for. When you click on the ID number of your site a new webpage will pull up and will show you general information about that site. Do a brief review to make sure all the information is correct.
4. Click on the "QUESTIONS" tab and start working your way through the twelve questions. Using the SWPPP for the site and your completed ACFCE, fill out the questions. If you aren't sure about an answer, the State has given little explanation boxes that are imbedded into almost every question, which give more detail on how to answer that specific question.

Tip: For questions 7 & 8 use the MIP of your SWPPP for answers to your questions. In the MIP you will find information on outfalls, the 303d list, and alternative outfall discharge locations!

5. Once all questions are completed, any documentation such as SWPPP revisions or other explanation documentation should be uploaded to the annual report. If there are no attachments necessary, you may move to the "CERTIFY" tab by selecting next. After ensuring that your attachments are all on SMARTS, click on the "PERFORM COMPLETION CHECK" tab.
6. If you are not an LRP, the annual report will be sent to an LRP and they will certify it. If you are a LRP or DAR you can now review and certify the annual report by selecting the check box and entering your password and answering a security question. You will then need to select "CERTIFY ANNUAL REPORT". A conformation screen will pop up and you can print out a copy for your records.

Smart on SMARTS?

As you fill out your annual reports, here are a few tips on how to use SMARTS.

With the high amount of traffic on the SMARTS website, sometimes you can encounter frustrating problems as you try to log onto SMARTS or maneuver your way around the website. Here are a few tips and tricks that we have learned over the years of our usage of SMARTS.

1. Use Explorer 11 as your web browser.

SMARTS recommends using Explorer 11 when using SMARTS. While Explorer 11 works for the most part, if you are still encountering problems with logging onto SMARTS, try using Google Chrome. Chrome sometimes supports SMARTS better than Explorer 11. We suggest you don't use Firefox as your browser. It isn't as compatible with SMARTS as are Chrome and Explorer 11.

2. Stay logged in.

If you are working for an extended period of time on SMARTS stay logged in. Logging out and re-logging back in can cause the website to freeze up.

3. Try submitting your annual reports on off hours of SMARTS.

We have noticed that working on SMARTS on off hours tends to speed up the website and have less problems when maneuvering around the SMARTS system. But we have also noticed that the webpage may be down during the weekend and early in the morning as it is updated and worked on.

4. Get your annual report done early.

The SMARTS website is highly trafficked, and waiting until the last minute to submit your annual report on SMARTS can be a little risky. Get your annual reports submitted early on and beat the website traffic. The closer to the deadline for annual reports, the harder it is to get onto SMARTS.

5. Logout and re-log into SMARTS.

If all else fails, log out of SMARTS and re-log in. Repeat until you can log into SMARTS.
